- 8. Westside Downtown (Cherie Buckner-Webb) Park, 1100 W Bannock St, Boise, ID 83702 planted 33 trees between March 16, 2021 & June 1, 2021
- 9. Bowler Park, 4403 S Surprise Way, Boise, ID 83706 planted 39 trees on June 9, 2021
