## 2. Have there been changes in land ownership of the Project Area?

On February 20th, 2025, legal land ownership of one of the two land parcels on site 6 (Parcel R20562) was changed from Rachel Thompson to MUNOZ, DANIEL & GRISELDA. The new landowners have been mailed a copy of the carbon credit compliant deed amendment that is attached to the property, as well as a letter that describes the objectives of the project and outlines the restrictions on mowing over, cutting down, or otherwise damaging any trees that are growing within the areas registered to this project.

3. Have there been any changes in the Project Design?

No.

4. Have there been any changes in the implementation or management of the Project?

No replants are planned for the 2025 planting season.

In response to high mortality rates among trees due to prolonged drought conditions, TreeFolks has replanted Sites 7, 12, and 14 in December of 2024.

**Site 7:** Replanted December 5th, 2024. 1,234 trees were replanted across 1.54 acres of the total planting area. 56 of these trees were planted using Groasis boxes, and had a survival rate of 42.8%.

**Site 12**: Replanted December 2nd, 2024. 2,097 trees were replanted across 4.70 acres of the planting site. 134 of these trees were planted using Groasis boxes, and had a survival rate of 56%.

**Site 14:** Replanted December 2nd, 2024. 533 trees were replanted across 0.84 acres of the planting site. No Groasis boxes were used at this site.

In total, 3,864 trees were replanted in December of 2024.

- 5. Have there been any significant changes to the site (such as flooding or human changes)?
  No.
- 6. Have there been any significant tree or canopy losses estimated to be greater than 10% of Project Trees or 10% of the canopy?

Since the last annual monitoring report, drought conditions have continued in Central Texas. We do not expect this to impact the ability of the project to reach the canopy cover milestones required for credit issuance, as trees were planted in a density far exceeding the minimum spacing requirements, with the expectation of high mortality rates. In addition, substantial natural recruitment of trees has been observed at many of the sites.

7. Do you anticipate future canopy loss (such as a new pest or disease issue found)?

We do not expect any of the newly established canopies to be lost. No new issues have been found.
