1. Has the contact information for the Project Operator changed? If so, provide new contact information.

2. Have there been changes in land ownership of the Project Area?

On April 11th, 2024, the legal ownership of site 11 (Parcel ID R94594, Bastrop County) changed from Robert and Margaret Graham to John Joseph Brockman and Kari Grace Kempf. The new landowners have been mailed a copy of the carbon credit compliant deed amendment that is attached to the property as well as a letter that describes the objectives of the project and outlines the restrictions on mowing over, cutting down, or otherwise damaging any trees that are growing within the areas registered to this project.

All other sites remain under the same ownership as was documented during initial crediting.

3. Have there been any changes in the Project Design?

4. Have there been any changes in the implementation or management of the Project?

In response to high mortality rates among trees due to prolonged drought conditions, TreeFolks has been in the process of replanting 9 of the 15 sites registered to this project.

Below is a brief description of the replanting efforts.

- Feb 2023 - 1,847 trees replanted across 6.34 acres (Sites: 3, 7)
- Feb 2024 - 4,274 trees replanted across 8.67 acres (Sites: 1, 5, 7, 9, 12, 13, 15)
- *Nov & Dec 2024 - 3,660 trees to be replanted across 6.09 acres (Sites: 7, 12, 14)
 - Note: The numbers for Nov & Dec 2024 are estimates.

In addition 190 groasis boxes will be installed during replanting at two of the sites that will be planted this November and December, Site 7 and Site 12. These boxes are used to fight desertification through reforestation, and have been shown to significantly improve the survival of the trees they are planted with.

5. Have there been any significant changes to the site (such as flooding or human changes)?

6. Have there been any significant tree or canopy losses estimated to be greater than 10% of Project Trees or 10% of canopy?

Since the last annual monitoring report, drought conditions have continued in Central Texas. We do not expect this to impact the ability of the project to reach the canopy cover milestones required for credit issuance, as trees were planted in a density far exceeding the minimum spacing requirements with the expectation of high mortality rates. In addition, substantial natural recruitment of trees has been observed at many of the sites.


7. Do you anticipate future canopy loss (such as a new pest or disease issue found)?
