

### **3. Project Location**

The two 5-acre parcels acquired are located in the Reservation Woods Acquisition Area in unincorporated Kendall County, Illinois (See attached "Exhibit A"). The parcels were purchased by the Kendall County Forest Preserve District in 2021, a conservation-focused county municipal government agency. The parcels are located within the headwaters of Morgan Creek, a tributary of the Fox River.
