The current address for the parcel is 1708 S. 700 W., New Palestine, IN 46163 and the Project Area is located in the Indianapolis Metropolitan Planning Organization. The property is in Hancock County. The parcel number for the site is 30-09-11-400-012.000-012.

The property was left to the Central Indiana Land Trust in 2022 by the estate of Marjorie Jones. We are the owners of the property and our goal for the forest is to protect and steward the forest in perpetuity.

The entire property is 77.25 acres, of which 22.4 acres is forested habitat. In the forested habitat 10 acres is very mature forest with old growth oak and hickory. There is a 12.4-acre portion made up of maple, walnut, hackberry and sycamore needing invasive species control. The property is zoned R2.5 – single family residential. The property has development on all sides of it with a new housing development with houses currently being built at the south boundary.

5. Project Impacts

Our goal is to have a simple trail through the north part of the forested area that will be open to the public free of charge. This highly developed area has very little public recreation areas. Part of the forested area is riparian forest along Breier Creek. Breier Creek flows through the forested part of the property and its waters eventually flow into Sugar Creek which is home to important wildlife such as river otters and freshwater mussels. Additionally, because of the encroaching development surrounding this forest keeping the habitat protected will slow flood waters allowing it to slowly recharge the groundwater system while trapping sediment, improving water quality.
